April Election

The Spring Election will be held on Tuesday, April 7th. Polls will be open from 7:00 A.M. to 8:00 P.M. Races on the ballot include Wisconsin Supreme Court, County Judge Races, Town Chairman, Town Supervisor I, Town Supervisor II, Town Clerk, Town Treasurer, DeForest, Lodi, Poynette and Waunakee School District Board Races, a DeForest School Referendum and a Wisconsin Constitutional Amendment question for selection of the Supreme Court Chief Justice. Sample ballots by school district are posted at the Town Hall and on the Town website under the Election tab. Inside this newsletter you will find candidate profiles for the two residents running for Town Supervisor I. On March 23, 2015 it was announced that the U.S. Supreme Court will not hear the Wisconsin Voter ID case. **There is not enough time to implement it for this election** because absentee ballots have already been sent out. It will likely be in effect for future elections. More information will be included in future newsletters as it becomes available.

Electronics Recycling

We will be having our electronics recycling day on Saturday, April 18, 2015 from 8:00 A.M. to Noon. We will be using the cold storage building with driveway access off Norway Grove Road. Items accepted for recycling include: Desktop and laptop computers, computer printers, fax machines, scanners, copiers, computer monitors, televisions, keyboards, DVD players, VCRs and cell phones. Microwave ovens will be accepted this year. **Please do not bring dehumidifiers or other appliances.** We will NOT be able to take items in advance, so if you are unable to make it on April 18, please make arrangements with a family member or neighbor to have them drop the item(s) off for you. **This free recycling event is limited to Town of Vienna residents. If you have heavy items, bring someone to help you unload them, as we will not have staff here to do that for you.**

The Town of Vienna has an ordinance prohibiting dogs running at large. We have received calls about dogs running at large in the subdivisions, as well as owners not picking up after their dogs. Please be responsible owners and good neighbors. Keep track of your dogs and where they do their business. Your neighbors should not have to clean up after your dog.

Pulse Point-Save a Life, Get the App

PulsePoint® Respond is a mobile application that lies at the intersection of technology, innovation, and Emergency Medical Services (EMS). Based on a smartphone's GPS coordinates, PulsePoint® Respond alerts CPR-trained bystanders to someone nearby who is having a sudden cardiac event that may require CPR. The mobile app is activated by the Dane County Public Safety Communications Center simultaneously with the dispatch of local EMS and fire resources.

The purpose of the mobile app is to increase the survival rates of cardiac arrest victims by:

1. Reducing collapse-to-CPR time by increasing citizen awareness of cardiac events beyond a traditional "witnessed" area.
2. Reducing collapse-to-defibrillation times by increasing awareness of public access to automatic external defibrillator (AED) locations through real-time mapping of nearby devices.

The mobile app is only activated if the event is occurring in a public place (the app is not activated for residential addresses). The CPR alerts appear just as other notifications on a smartphone, such as texts or voicemails but with a distinctive alert tone. The app also shows the location of the nearest AED, provides directions to the AED in real-time in context with the responders' current location. In addition to the life-saving CPR/AED functionality, the app provides a window into EMS and Fire activity in your community, offering a unique opportunity for civic engagement and transparency. Town of Vienna Board Meeting Minutes

Monday, March 2, 2015

The meeting was called to order at 7:00 P.M. by Chairman Lonnie Breggeman. Supervisors Gary Endres, Jeff Freppon, Dave Ripp, Ron Rupp and Clerk Shawn Haney were present. Also present: Karen Ingalls, Steve Ruegsegger, Charles Linde, Jim Koltes, Dustin Kelley (7:03P.M.) and Dennis Kelley (7:03 P.M.)

After the Pledge of Allegiance there was a motion by Endres, 2nd by Ripp to approve the minutes of the February 16, 2015 regular board meeting. All yes.

Public comment: None.

DeForest Senior Center – Our portion of the \$150,000 purchase price for the former UW Clinic property is \$4,800. The resolution previously passed stated that each municipality is responsible for funding their portion. It is a one-time expense that can be taken from General fund reserves. We also have money in a pre-development account that could be used. Motion by Endres, 2nd by Rupp to take the \$4,800 from the pre-development account. All yes.

Plow Truck Equipment – The Equipment Committee reviewed equipment proposals from Burke Truck and Madison Truck. The Burke proposal was less money than the Madison Truck proposal. The recommendation is to accept the Burke proposal with the changes of adding the Insta Chain automatic traction system and changing the pre-wet system to electric instead of hydraulic. The price with these changes is \$63,741.00. Motion by Endres, 2nd by Rupp to accept the Equipment Committee recommendation to make the purchase from Burke Truck. All yes.

Town Hall Sign – Prices were obtained for two types of stand up signs. Susan Cary makes sandblasted wood signs similar to what several farms in the area have. Those signs run approx. \$85-\$100 per square foot. Signs by Tomorrow have Alumalite signs that would run \$160 to \$300 depending on size and color. There was discussion about using the same style lettering that is on the front of the building, on the side of the building facing County I. That lettering would also be visible from County V if it were placed high on the building. The clerk will obtain information and pricing on that style of lettering.

Resolution 03-02-15 Opposition to Changes in Property Assessment – The resolution was prepared by the Wisconsin Towns Association in opposition to the Governor's proposal to change local property assessment to a countywide system. It would eliminate local handling of Board of Review, increase costs to Towns and erode local control. Motion by ripp, 2nd by Freppon to adopt Resolution 03-02-15. All yes.

Operator's License(s) – Motion by Freppon, 2nd by Rupp to approve an Operator's License for Thomas Mitchell at Waunakee Gun Club. All yes. Motion by Rupp, 2nd by Ripp to approve an Operator's License for Tina Glynn at Waunakee Gun Club. All yes.

Town Supervisor Reports: Supervisor Rupp reported that DeForest Fire meets on Wednesday. Supervisor Ripp reported that Dane Fire met last week. They are hoping to have the audit results available by the end of March. Chairman Breggeman reported that the DeForest Senior Center meets next Tuesday. Supervisor Freppon reported that Waunakee EMS meets next Thursday. Supervisor Endres reported that Waunakee Fire met last week. They are still working on the specs for an ATV/UTV. It will be equipped so that it can be used in both summer and winter.

Town Clerk's Report

DaneCom Update – Information was provided to the board regarding the status of DaneCom. It is currently turned off and they are determining the next steps. Three to four additional tower sites need to be added. They are trying to deter-

- Small Claims Update – Mr. DeMarte sent an additional check for \$401.84. There was a bill from Columbia County for process service that we could try to collect but the cycle could go on forever. We will notify the court that the judgment has been paid and the contempt hearing will not need to be held on March 20, 2015.

- Town Hall Septic – The septic tank at the Town Hall froze up last week. They were able to get it chipped open enough to have the tank pumped. We will be researching options to prevent it from happening again. Those options include either insulating on top of the tank, or installing a pump on one side to pump out onto the drain field.

Motion by Rupp, 2nd by Freppon to pay current town bills in the amount of \$224,515.86 (Utility 1 = \$5,237.17, Utility 2 = \$334.50, Payroll = \$4,408.97, Loans = \$194,608.59 and Town General = \$19,926.63 All yes. (Clerk note: The Utility 1 loan was paid from Utility 1. The other loans were for the Town Hall, 2007 and 2009 road improvements, Hickory Lane UD 3, I90-94 bridge and Maier Road.

Town of Vienna Board Meeting Minutes

Monday, March 16, 2015

The meeting was called to order at 7:00 P.M. by Chairman Lonnie Breggeman. Supervisors Gary Endres, Jeff Freppon, Dave Ripp, Ron Rupp and Clerk Shawn Haney were present. Also present: Karen Ingalls, Steve Ruegsegger, Don Schmidt, Dustin Kelley, Dennis Kelley, Jim Koltes (7:08 P.M.) and Deputy Bennett (7:17 P.M.)

After the Pledge of Allegiance there was a motion by Endres, 2nd by Rupp to approve the minutes of the March 2, 2015 regular board meeting. All yes.

Public comment: None.

Kelley Split/Rezoning – Dennis and Dustin Kelly were present. They are requesting to split and rezone 2.88 acres from A-1ex to RE-1 on County Highway I north of County Highway DM. The split is for a single family residence for Dustin Kelley. The Plan Commission reviewed and recommended approval. The driveway permit will be issued by Dane County. Application has been made to the Village of DeForest as the land is in the ETZ area. That meeting will be held on April 13th. Motion by Ripp, 2nd by Freppon to approve the Plan Commission recommendation. All yes.

Town Hall Signage – The board reviewed a proposal from Quick Signs of Green Bay for lettering for the east side of the building. 18" letters are \$2,731.00 and 24" letters are \$4,239.60. Their quote also had a delivery fee of \$350.00 and an installation fee of \$1,235.00. There was discussion about putting the letters on the building vs. adding a wood/metal sign facing County I. If we put a sign on posts we may need to get permission from ATC as it would likely be in their right of way. It was suggested that we could pick up the items from the company and have our employees install them. Motion by Ripp, 2nd by Endres to purchase the 18" letters and have our employees pick up and install. All yes.

Operator's License(s) – None

Town Supervisor Reports: Supervisor Rupp reported that DeForest Fire has been meeting with EMTs to discuss personnel issues. Additional meetings will be held in the near future. Supervisor Ripp reported that Dane Fire meets on March 30th. Chairman Breggeman reported on the DeForest Senior Center. A walk through was done of the former clinic property. No asbestos was discovered. Supervisor Freppon reported that Waunakee EMS has hired a new Service Director. Scott Russell will start on April 1, 2015. Supervisor Endres reported that Waunakee Fire meets on March 30th.

Deputy Bennett – Deputy Bennett arrived at 7:17 P.M. and gave his report. He provided a list of calls in the Town from October 1, 2014 through February 26, 2015. Deputy Bennett stated that charges have been brought against and individual for illegally running a drug rehab house on County DM. An eviction was done and the drug rehab house is no longer being operated. Deputy Bennett asked the board and audience if they had any concerns they wanted to pass along to him. Chairman Breggeman asked if Deputies could watch County Highway V for drivers passing stopped school busses. The violations are primarily occurring in the mornings. Don Schmidt asked about additional enforcement of the 35 mph speed limit in the Interstate business area.

Town Clerk's Report

- Town Hall Septic – The septic tank has been thawed out with the use of a heat lamp. LMS gave a proposal of installing a pump at a cost of \$900 plus wiring, or digging up and insulating on top of the tank at a cost of \$1,450. After discussion it was decided to not do either. We will attempt insulation on top of the ground by other methods next year to see if the problem reoccurs.

- Clear Horizons Update – A check was sent to the town in late February, but it included an amount that was due by January 31st for real estate taxes. We could not accept that payment after January 31st. The check was returned to Clear Horizons with instructions for them to contact Dane County for the amount due for the real estate portion, with a separate check to be made payable to us for the amount in the agreement amendment.

- Seasonal Weight Limits – The seasonal weight restrictions were put on the roads on Friday, March 13th. We use the Wisconsin DOT guidelines when placing the restrictions on our roads. They will remain on until the frost comes out of the ground.

Supervisor Ripp inquired about using uncommitted funds in the Town Hall account to pay down the debt on the Town Hall loan. It will placed on the agenda for the April 7, 2015 Town Board Meeting.

Motion by Rupp, 2nd by Endres to pay current town bills in the amount of \$59,785.31 (Utility 1 = \$25.92, Utility 2 = \$115.81, Payroll = \$4,286.97, Truck Equipment Deposit = \$32,340.00 and Town General = \$23,016.61 All yes.

Meeting was adjourned at 7:50 P.M.
